REPORTS FROM MAYOR AND/OR DEPARTMENT HEADS

Mayor Fleisher opened by recognizing the line-of-duty death of Camden City Firefighter Howard Bennett and expressed condolences to his family and the Camden community. He thanked Cherry Hill's fire, EMS, police, and civilian staff for their service and encouraged residents to review recent Fire and Police Department safety initiatives.

He highlighted recent community events, including attending the Cherry Hill Special Education PTA Winter Family Fun Night, recognizing local Eagle Scouts, participating in Super Sunday and Mitzvah Day, and meeting residents who have made notable contributions, including a Cherry Hill East student who helped save a coworker's life and a local restaurateur named a James Beard semifinalist. He also met with Cherry Hill residents honored with Camden County's MLK Freedom Medals.

The Mayor noted items on the agenda related to grant applications for recreation, substance abuse prevention, and recycling efforts. He announced the upcoming launch of the Thrive After 55 Senior Needs Assessment survey and encouraged participation.

He recognized February as American Heart Month and National Cancer Prevention Month and promoted an upcoming Mayor's Wellness Walk. He also extended well wishes to residents observing Ramadan and the Lunar New Year and closed by thanking residents for being part of the Cherry Hill community.

Mr. Podowitz urged Council to advocate for changes to New Jersey's school funding formula, arguing that its reliance on income unfairly shortchanges districts like Cherry Hill and asking local and state leaders to take action.

Mr. Short expressed concern that what he described as "ICE hysteria" in Cherry Hill Township—including social media reactions, school discussions, and public statements—was unfairly demonizing immigration enforcement and urged officials to help calm tensions.

Ms. Einhorn asked Cherry Hill Township officials to try to preserve the historic clock from the Cherry Hill Diner as a display or memento to honor the township's history.

After seeing no further comments, Council President Carter closed the Public Comment.

COMMENTS OF COUNCIL

Councilwoman Apell thanked community members for participating in the Jewish Federation of Southern New Jersey Super Sunday and Mitzvah Day events that support residents of all backgrounds and invited the public to view the iHeart Art Youth Art Program exhibit at Croft Farm Arts Center through February 22.

Councilman Connor thanked residents for participating in the meeting, praised the Department of Community Development—especially Kathy Cullen's team—for their Zoning Board report recognizing dedicated volunteers, and highlighted the informative Cherry Hill Citizens Police Academy session led by Sergeant Amato as a valuable community resource.

Councilman DiRenzo noted that he and Mayor Fleisher attended a Boy Scouts of America Eagle Scout Court of Honor recognizing Cherry Hill residents John Francis Miller III, Anthony John Parrone IV, and John Patrick Claffee, praising their significant achievement and the community service projects that demonstrated leadership and hard work.


