**RESOLUTION TO AUTHORIZE EXECUTION OF COLLECTIVE
BARGAINING AGREEMENT WITH I.A.F.F. CIO/CLC LOCAL 3249
EMERGENCY MEDICAL TECHNICIANS AND PARAMEDICS**

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, and I.A.F.F. AFL-CIO Local No. 3249, Cherry Hill Emergency Medical Technicians and Paramedics in Cherry Hill Township have entered into negotiations for a collective bargaining agreement; and

WHEREAS, the Board of Fire Commissioners for Fire District #13 and the I.A.F.F. AFL-CIO Local No. 3249, Cherry Hill Emergency Medical Technicians and Paramedics have concluded negotiations for a collective bargaining agreement effective January 1, 2017 through December 31, 2019; and

WHEREAS, the Board of Fire Commissioners for Fire District #13 and the I.A.F.F. AFL-CIO Local No. 3249, Cherry Hill Emergency Medical Technicians and Paramedics, desire to implement said collective bargaining agreement as quickly as possible;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a collective bargaining agreement with I.A.F.F. AFL-CIO Local No. 3249, Cherry Hill Emergency Medical Technicians and Paramedics, effective January 1, 2017 through December 31, 2019, a copy of which is on file, subject to review of all calculation and appendices and approval of counsel.


The following Resolution #17-10-05-03 was introduced by Commissioner Campagna and it was seconded by Commissioner Gibson . Motion carried.
