**RESOLUTION AUTHORIZING THE RENEWAL OF THE SHARED SERVICES AGREEMENT

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey and the Township of Cherry Hill, County of Camden, State of New Jersey have previously negotiated and approved a Shared Services Agreement that provides for Emergency Management Services; and

WHEREAS, the Board of Fire Commissioners for Fire District #13, and the Township of Cherry Hill desire to renew said agreement with revisions effective from October 25, 2018 to October 25, 2028; and

WHEREAS, the State of New Jersey has defined the procedures for the execution of any agreement, and the Agreement between Cherry Hill Fire District #13 and the Township of Cherry Hill shall be governed by the Shared Services Act, *N.J.S.A 40A:651 et seq* and the Local Public Contracts Law, *N.J.S.A 40A11-1 et seq*.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a Shared Services Agreement with the Township of Cherry Hill, County of Camden, State of New Jersey, a copy of which is on file and made a part hereof


