WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey and the County of Camden, State of New Jersey have entered into a Contract Agreement that provides for the Juvenile Justice Commission grant administration and management of the 2019 Fire Watch Program in the amount of \$37,000.00; and

WHEREAS, the Board of Fire Commissioners for Fire District #13 are prepared to accept the responsibility to provide administration and management services for the 2019 Fire Watch Program Services on behalf of the County and under the Juvenile Justice Commission grant for the period January 1, 2019 through December 31, 2019; and

WHEREAS, the Board of Fire Commissioners for Fire District #13, and the County of Camden agree that their mutual public purposes and their best interest will be promoted by the execution and delivery of this Contract Agreement; and

WHEREAS, the State of New Jersey has defined the procedures for the execution of any Contract, and the Contract between the District and the County shall be governed by the Local Public Contracts Law, *N.J.S.A 40A11-1 et seq.*

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a Contract Agreement with the County of Camden, State of New Jersey, a copy of which is on file and made a part hereof.
