**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR  
LEGAL SERVICES WITH THE LAW OFFICE OF QUINLAN & NIGRO, LLC**

**WHEREAS**, the Cherry Hill Fire District #13 has a need to acquire legal services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

**WHEREAS**, the Cherry Hill Fire District #13 has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

**WHEREAS**, the anticipated term of this contract is from April 1, 2019 through December 31, 2019; and

**WHEREAS**, the Law Office of Quinlan, Nigro, LLC has submitted a proposal indicating it will provide the legal service pursuant to the proposal at an hourly rate of \$230.00 for Timothy Quinlan and \$200.00 for Patricia Nigro not to exceed \$30,000.000; and

**WHEREAS**, the Law Office of Quinlan & Nigro, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that the Law Office of Quinlan & Nigro, LLC has not made any reportable contributions to a political or candidate committee in Cherry Hill Fire District #13 in the previous one year, and that the contract will prohibit the Law Office of Quinlan & Nigro, LLC from making any reportable contributions through the term of the contract; and

**WHEREAS**, the Fire District has determined that funds are available concerning the projected expenditures.

**NOW, THEREFORE, BE IT RESOLVED**, that the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, authorize the Fire District to enter into a contract with the Law Office of Quinlan & Nigro, LLC as described herein; and

**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.


