**RESOLUTION APPROVING THE ADDITION OF ITEM OF REVENUE AND
APPROPRIATIONS TO THE 2019 FIRE DISTRICT BUDGET – SCBA EQUIPMENT GRANT**

WHEREAS, NJSA 40A:14-78.5 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any Fire District when such item shall have been made available by law and the amount was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of an item of appropriation for an equal amount,

NOW, THEREFORE, BE IT RESOLVED, that the Fire District # 13 of the township of Cherry Hill in the County of Camden, New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2019 in the sum of \$210,363.63, which is now available from the Federal Emergency Management Agency (FEMA); and

BE IT FURTHER RESOLVED, that the like sum of \$210,363.63 is hereby appropriated under the caption SCBA Equipment Grant; and

BE IT FURTHER RESOLVED that the sum of \$21,036.37 represents the amount required for the Fire District's share of the aforementioned undertaking or improvement and appears in the budget of 2019 under the caption Other Assets, Non-Bondable #1 and is hereby re-appropriated under the caption SCBA Equipment Grant.
