**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR
MEDICAL EXAMINATION SERVICES WITH INTERSTATE MOBILE CARE**

WHEREAS, the Cherry Hill Fire District #13 has a need to acquire medical examination services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Cherry Hill Fire District #13 has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the anticipated term of this contract is for the year January 1, 2020 through December 31, 2020; and

WHEREAS, INTERSTATE MOBILE CARE has submitted a proposal indicating it will provide the various medical examination services not to exceed \$46,000.000; and

WHEREAS, Interstate Mobile Care has completed and submitted a Business Entity Disclosure Certification which certifies that Interstate Mobile Care has not made any reportable contributions to a political or candidate committee in Cherry Hill Fire District #13 in the previous one year, and that the contract will prohibit Interstate Mobile Care from making any reportable contributions through the term of the contract; and

WHEREAS, the Fire District has determined that funds are available concerning the projected expenditures.

NOW, THEREFORE, BE IT RESOLVED, that the Commissioners of Fire District #13 in the Township of Cherry Hill, County of Camden, authorize the Fire District to enter into a contract with Interstate Mobile Care as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.


