**RESOLUTION AUTHORIZING TERM PRICING CONTRACT FOR THE PURCHASE OF
TOPPS NOMEX UNIFORMS OR EQUIVALENT PROJECT # FF2020-005**

WHEREAS, the Board of Fire Commissioners, District #13, has a need to procure uniforms in a timely manner that are to be issued to Firefighter personnel to wear while in performance of their assigned duties; and

WHEREAS, the Board of Fire Commissioners, District #13, in accordance with N.J.S.A. 40A:11-1 et seq., the Local Public Contracts Law, has duly advertised bid specifications for a project entitled Purchase of Topps Nomex Uniforms or Equivalent Project # FF2020-005 to establish a ready source for the procurement of these uniforms; and

WHEREAS, the Board of Fire Commissioners, District #13, through this resolution and properly executed contracts, intends to establish a term pricing contract with the lowest responsible bidder for this project with no guarantee as to the minimum or maximum volume of purchase; and

WHEREAS, after bids had been received and reviewed, Action Uniform Co. LLC, 3164 Fire Road, Egg Harbor Twp., NJ 08234 was determined to be the lowest responsive and responsible bidder;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that a One (1) Year with the option to renew for a Second (2nd) year term pricing contract for the Purchase of Topps Nomex Uniforms or Equivalent is hereby awarded to Action Uniform Co., LLC; and

BE IT FURTHER RESOLVED, that the duration of the term contract between the Board of Fire Commissioners, District #13 and Action Uniform Co., LLC, shall be from October 9, 2020 to October 8, 2021; and

BE IT FURTHER RESOLVED that the second year, if desired, shall be awarded at the October Board of Fire Commissioners Fire District #13 meeting in the year 2021; and

BE IT FURTHER RESOLVED, that the Board of Fire Commissioners, Fire District #13 authorizes the Purchasing Manager to procure these uniforms on an as-needed basis based on the unit prices submitted by Action Uniform Co., LLC for the term of this award, pursuant to all conditions of the bid specifications, without any further action; and

BE IT FURTHER RESOLVED, that, pursuant to N.J.A.C. 5:30-5.5(b), the Purchasing Manager must notify and seek the certification of availability of funds from the Finance Officer prior to the placing any orders for goods or services related to this project.
