**RESOLUTION AUTHORIZING ORDERING OF VEHICLE EXTRICATION EQUIPMENT
GRANT # EMW-2019 – FG - 02451**

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order vehicle extrication equipment with funding provided by a Federal Grant # EMW-2019-FG-02451 for use by the Department; and

WHEREAS, the Fire District is a member of the State of New Jersey Department of Treasury, Division of Purchase and Property state contact NJSTART which can be utilized to order Genesis Rescue Tools through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11 et seq. without further competitive bidding; and

WHEREAS, the Genesis equipment with various published and unpublished options described meets the standards, specifications and requirements of the Cherry Hill Fire Department;


