**WHEREAS**, the State of New Jersey has defined the procedures for the execution of any Contract and the Contract between the District and the County shall be governed by the Local Public Contracts Law, *N.J.S.A 40A11-1 et seq.*

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a Contract Agreement with the County of Camden, State of New Jersey, a copy of which is on file and made a part hereof.


