RESOLUTION MEMORIALIZING THE APPOINTMENT OF A FIRE MARSHAL/FIRE OFFICIAL

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of a Fire District may by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District; and

WHEREAS, the Board of Fire Commissioners, District #13, Cherry Hill, New Jersey has determined that the position of Fire Marshal/Fire Official of the Fire District and the salaries and benefits for such positions previously established, has been created, and

WHEREAS, the Board of Fire Commissioners has determined that the Fire Marshal/Fire Official position needs to be filled to continue to promote the safety of the public they serve; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that the Board of Fire Commissioners is hereby authorized to appoint Joseph V. Cornforth, Fire Marshal/Fire Official effective April 30, 2021.

BE IT FURTHER RESOLVED by the Board of Fire Commissioners, District #13, that the individual appointed to the position of paid Fire Marshal/Fire Official of the Fire District shall be subject to a review twelve (12) months following the date of appointment by the Chief of Department who shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A:14-70 et seq.


