**RESOLUTION SETTING THE COMPENSATION FOR MEMBERS OF
THE BOARD OF FIRE COMMISSIONERS**

WHEREAS, N.J.S.A. 40A:14-88 states that each member of the Board of Fire Commissioners shall receive as compensation such amounts as the Board shall fix; and

WHEREAS, N.J.S.A. 40A:14-88 states that the compensation so fixed shall be subject to review by the governing body wherein the Fire District is located; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey that the Board of Fire Commissioners shall be compensated on an annual basis as follows: each Commissioner shall receive a salary of \$7,000.00 per year except that the Commissioner who has been elected as Chairperson shall receive compensation of \$8,000.00 per year and the Commissioner who has been elected as Treasurer shall receive compensation of \$8,000.00 per year for a combined total of \$37,000.00;

BE IT FURTHER RESOLVED that said compensation shall be paid monthly to the Commissioners; and

BE IT FURTHER RSOLVED that in order to receive this compensation each Commissioner must attend eighty percent of all commission meetings. If a Commissioner attends less than eighty percent of all commission meetings his or her salary shall be reduced on a pro-rated basis; and

BE IT FURTHER RESOLVED that this resolution shall be forwarded to the governing body of the Township of Cherry Hill for its review.

The following Resolution #21-10-18-05 was introduced by Commissioner Kelly and it was seconded by Commissioner Lipsett. Motion carried.
