**RESOLUTION TO AUTHORIZE EXECUTION OF COLLECTIVE

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a collective bargaining agreement with I.A.F.F. AFL-CIO Local No. 3249, Cherry Hill EMS Officers, effective January 1, 2020 through December 31, 2024, a copy of which is on file, subject to review of all calculation and appendices and approval of counsel.
