**RESOLUTION AUTHORIZING AN AWARD OF THE OPTION YEAR #1/2022 FOR
CONTRACT FOR GRASS CUTTING, TRIMMING, EDGING AND GROUNDS KEEPING**

WHEREAS, the Township of Cherry Hill, Cherry Hill Fire Department and the Cherry Hill Public Library, joined in a combined effort in securing a landscaper to furnish all labor, materials, supplies, parts, equipment and services to perform grass mowing and trimming at various Township properties, Cherry Hill Fire Department properties and the Cherry Hill Public Library; and;

WHEREAS, this contract was awarded as "fair and open" pursuant to N.J.S.A. 19:44A-20.5 and in addition to N.J.S.A. 40A:11-1 et seq., Township Resolutions 2006-1-51 and 2008-10-10, Township Ordinances 2007-21 and 2008-9; and

WHEREAS, the Board of Fire Commissioners, Fire District #13, approved this service by resolution #21-05-17-03 with two (2) one (1) year options to be executed at the discretion of the Fire District with set pricing of \$9,280.00 for the 2022 season and \$9,760.00 for the 2023 season.

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that the optional year #1/2022 contract for grass cutting, trimming, edging and grounds keeping for the 1100 Markkress Road Headquarters, Station 3 and 301 Burnt Mill Road, Fire Police Station is awarded to TLC Landscape Co., 701 Clayton Road, Williamstown, NJ 08094 for a total amount not to exceed \$9,280.00 for the 2022 season:
