WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order Firefighter Elkhart Brass Apparatus Nozzles and Associated Appliances with funding provided by an existing budget for use by the Department; and
