**RESOLUTION AUTHORIZING THE ISSUANCE OF A PURCHASE ORDER FOR KEY HOSE
BIG 10 – 1.75" & 2"**

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, solicited for quotes as required and in accordance to N.J.S.A. 19:44A-20.4 et seq. set forth by the State Local Unit Pay-to-Play law for KEY HOSE BIG 10 – 1.75" & 2"; and

WHEREAS, quotes were solicited from the following fire hose providers with award based on unit pricing:

Continental Fire and Safety: Total: \$43,920.00

- KEY #DP18-800-FDNY 1.75" x 50' x 1.5" NH CPLGS BIG-10 FDNY SPEC HOSE: **135 @ \$ 175.00 = \$23,220.00**
- KEY #DP25-800 2.5" x 50' x 2.5" NG CPLGS BIG-10 HOSE: **100 @ 207.00 = \$20,700.00.**

1st Choice Safety Equipment: \$46,019.75

- KEY #DP18-800-FDNY 1.75" x 50' x 1.5" NH CPLGS BIG-10 FDNY SPEC HOSE: **135 @ \$ 179.85 = \$24,379.75**
- KEY #DP25-800 2.5" x 50' x 2.5" NG CPLGS BIG-10 HOSE: **100 @ 216.40 = \$21,640.00.**

All Hands Fire Equipment: \$54,055.00

- KEY #DP18-800-FDNY 1.75" x 50' x 1.5" NH CPLGS BIG-10 FDNY SPEC HOSE: **135 @ \$ 213.00 = \$28,755.00**
- KEY #DP25-800 2.5" x 50' x 2.5" NG CPLGS BIG-10 HOSE: **100 @ 253.00 = \$25,300.00.**
