**RESOLUTION AUTHORIZING CONTRACT VENDORS FOR CONTRACTING UNITS  
PURSUANT TO N.J.S.A. 40A:11-12a IN CONTRACT YEAR 2023 – (STATE CONTRACT  
VENDORS)**

**WHEREAS**, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, pursuant to N.J.S.A 40A:11-12a and N.J.A.C. 5:34-7.29, may by resolution and without advertising for bids, purchase any goods or services under State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

**WHEREAS**, the Board of Fire Commissioners, Fire District #13 has the need on a timely basis to purchase goods or services utilizing State contracts; and

**WHEREAS**, the Board of Fire Commissioners, Fire District #13 intends to enter into contracts with the following State Contract Vendors listed on Exhibit A through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey authorizes the Purchasing Manager to purchase certain goods or services from the approved New Jersey State Contract Vendors as listed in Exhibit A pursuant to all conditions of the individual State contracts; and

**BE IT FURTHER RESOLVED**, that the governing body of the Board of Fire Commissioners, Fire District #13, pursuant to N.J.A.C 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer.


