**RESOLUTION AUTHORIZING THE ADVERTISING OF BIDS FOR
OPERATING LEASE FOR THREE (3) AMBULANCES PROJECT #EMS2023 - 012**

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey has determined that they will advertise for sealed bids for a bid entitled Operating Lease for Ambulances Project #EMS2023 - 012 and;

WHEREAS, current leases for three (3) ambulances will expire; two in June and one in July of 2023 respectively, with previously ordered ambulances tentatively scheduled for delivery on these dates barring delays caused by supply chain issues and;

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, authorizes the Purchasing Manager as follows:

1. Prepare detailed specifications for this project and provide same to assure that the services will be obtained through a fair and open process and will meet the functional and operational needs of Fire District #13.
2. The Purchasing Manager shall advertise and receive sealed bids for the above-named purpose or project at the appropriate time when ambulance delivery dates are secured.

BE IT FURTHER RESOLVED, that the governing body of the Board of Fire Commissioners, Fire District #13 pursuant to N.J.A.C 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer


