RESOLUTION AUTHORIZING THE DISPOSAL OF THREE VEHICLES NO LONGER STREET WORTHY WHICH WILL BE USED FOR TRAINING PURPOSES

WHEREAS, the District has three vehicles identified in the attached Exhibit A and incorporated herein, which are no longer needed for public use, which are not currently street-worthy and which the cost of repair far exceeds their value for continued use in the District;

WHEREAS, the District believes the best use of the vehicles is for training purposes for the firefighters and rescue operations; and

WHEREAS, post training, the scrap materials will be taken by a recycler in exchange for the cost of removal;

NOW THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of the Cherry Hill Fire District #13, County of Camden, State of New Jersey, that:

1. The vehicles identified in Exhibit A are declared no longer street worthy and the cost of repair far exceeds the value of the vehicles.
2. The value of the vehicles as training material exceeds the value the District could gain through sale by auction;
3. Once training is completed, the District shall allow a salvage yard to remove the vehicle parts in exchange for the cost of removal.
4. District Administration shall take all necessary action to transfer title, notify the Department of Motor Vehicles, and remove the vehicles from insurance and the District's asset lists and any other action necessary in the fulfillment of this Resolution.


