**RESOLUTION AUTHORIZING THE ISSUANCE OF A CONTRACT FOR ON-LINE
MARKETPLACE FOR THE PURCHASES OF PRODUCTS AND SERVICES**

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey pursuant to LFN 2012-10 dated May 14, 2012, P.L. 2011, c.139 (the "Law" or "Chapter 139") allows local contracting units to utilize cooperative contracts may by resolution and without advertising for bids, purchase any goods or services using National Cooperative Contracts in accordance of N.J.S.A. 52:34-6.2(b); and

WHEREAS, the Board of Fire Commissioners, Fire District #13 has the need for an online marketplace for the purchase of products and services; and

WHEREAS, the Board of Fire Commissioners, Fire District #13 is a member of the Omnia Partners national service cooperative; and

WHEREAS, the Board of Fire Commissioners, Fire District #13 intends to enter into the Omnia Partners contract R-TC-17006 with Amazon Business for a two-year period or the expiration of the cooperative contract, whichever occurs first, through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State law, rules and regulations, and;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, authorizes the issuance of a two-year contract for an On-Line Marketplace for Purchase of Products and Services to Amazon Business.

BE IT FURTHER RESOLVED that the governing body of the Board of Fire Commissioners, Fire District #13 pursuant to N.J.A.C 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds is made by the Chief Financial Officer.


