RESOLUTION AUTHORIZING THE PURCHASE OF FIREFIGHTER PROTECTIVE CLOTHING AND EQUIPMENT

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has determined that a need exists to order Firefighter Protective Clothing and Equipment with funding provided by an existing budget for use by the Department; and

WHEREAS, the Fire District #13 is a member of the State of New Jersey Department of Treasury, Division of Purchase and Property and wishes to utilize a state cooperative purchasing contract to order Firefighter Protective Clothing and Equipment through their fair and open process that satisfies the requirements of the Local Public Contracts Law, N.J.S.A. 40A: 11 et seq. without further competitive bidding; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, that an order of Firefighter Protective Clothing and Equipment, in the amount of \$82,480.00 per quote number QT1904493, be placed with Municipal Emergency Services under the provisions of the State of New Jersey Department of Treasury, Division of Purchase and Property State Contract 17-Fleet-00810 (T-0790).


