**RESOLUTION MEMORIALIZING THE APPOINTMENT OF SIXTEEN CAREER
FIREFIGHTERS TO FILL EXISTING VACANCIES**

WHEREAS, N.J.S.A. 40A:14-81.1 states that the Commissioners of any Fire District may, by resolution, establish paid positions for the Fire District as such positions shall be determined by the Commissioners to be required for the purposes of the Fire District, and;

WHEREAS, the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden has determined that the position of firefighter of the Fire District and the salaries and benefits for such positions previously established and agreed upon contractually, has been created and previously established, and;

WHEREAS, the Board of Fire Commissioners has determined that sixteen (16) career firefighter positions are needed to be filled to continue to promote the safety of the public they serve, and;

WHEREAS, the Fire District has an established eligibility list from which to appoint; and

WHEREAS, the following requirements must be satisfied in order to continue with this process: Pass a Post Offer Psychological Examination; Pass a Post Offer Medical Examination which includes a Hair Follicle Drug Screening Test; successfully complete a Firefighter Recruit Academy; and Provide the Department with a NJ State Emergency Medical Technician Certification within one (1) year of employment. All course work is the responsibility of the candidate and not hours worked.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, and County of Camden that the Board of Fire Commissioners is hereby authorized to appoint the next eligible candidates: Raymond Conover, Travis Smith, John Ioannucci, Joseph Stowers, Albert Smith, Ryan West, Ryan Bax, Justin Arnold, Nathan Randazzo, Zachariah Katz, Charles Carpenter, Andrew Lloyd, Patrick Guilmette, Alexander Palacio-Valencia, William Lafferty and John Springer from said list, effective date of employment is September 26, 2025 for Training Orientation.

BE IT FURTHER RESOLVED, by the Board of Fire Commissioners, District #13, that any individual appointed to the position of career paid firefighter of the Fire District shall be subject to a review twelve months following the date of appointment by the Fire Chief of the Department. The Fire Chief of the Department shall have full and final discretion and authority to conduct this review and make recommendations subject to review and approval by the Board and pursuant to the provisions of N.J.S.A. 40A:14-1 et seq.
