**RESOLUTION TO INTRODUCE AND APPROVE BUDGET FOR
CALENDAR YEAR JANUARY 1, 2026 TO DECEMBER 31, 2026**

WHEREAS, the Annual Budget for the Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey for the fiscal year period beginning January 1, 2026 and ending December 31, 2026 has been presented for approval before the governing body of Fire District #13 at its open public meeting on December 18, 2025; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.)

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$36,924,763.00, which includes the amount to be raised by taxation \$29,893,879.00 and Total Appropriations of \$36,924,763.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, Fire District #13 has taken into account the assessed valuation of taxable property in Fire District #13.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Cherry Hill Fire District #13 at an open public meeting held on December 18, 2025 that the Annual Budget including appended Supplemental Schedules, of the Cherry Hill Fire District #13 for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amounts to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District #13's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the Cherry Hill Fire District #13 will consider the Annual Budget for adoption after a public hearing on January 21, 2026

The following Resolution #25-12-18-21 was introduced by Commissioner Arroyo and was seconded by Commissioner Doran. Motion carried.
