**RESOLUTION AUTHORIZING THE APPOINTMENT OF EB EMPLOYEE SOLUTIONS, LLC.
DBA AS THE DIFFERENCE CARD TO PROVIDE HRA SERVICES**

WHEREAS, the Cherry Hill Fire District is subject to certain requirements of the Local Public Contracts Law; and

WHEREAS, the Cherry Hill Fire District is authorized to offer health benefits coverage to all full-time employees; and

WHEREAS, Conner Strong & Buckelew on behalf of the Cherry Hill Fire District conducted a publicly advertised Request for Proposals (hereinafter "RFP") process, for HRA Services pursuant to New Jersey law; and

WHEREAS, it is the Cherry Hill Fire District's intention to offer our employees the opportunity to enroll in the Direct Access/Aetna Freedom HDHigh plan with a fully funded Health Reimbursement Account in the amount of **\$12,400.00** for each employee regardless of level of coverage (single, member/spouse, parent/child, family) to be effective July 1, 2026.

WHEREAS, the Entity resolves to award a professional service agreement in accordance with a fair and open process pursuant to N.J.S.A. 19:44A-20.4 et. seq.

NOW THEREFORE BE IT RESOLVED THAT:

1. The EB Employee Solutions, LLC, dba as The Difference Card (hereinafter the VENDOR) with a business address of 200 Business Park Drive, Suite 311, Armonk, NY 10504 is appointed to provide HRA Services for the period July 1, 2026 through December 31, 2026.

BE IT FURTHER RESOLVED THAT: All associated fees due to the Difference Card will be paid directly to vendor.

BE IT FURTHER RESOLVED THAT: John Foley, Chief Financial Officer is hereby authorized to execute contracts between the ENTITY and The Difference Card as set forth in this resolution.


