**RESOLUTION AUTHORIZING THE INSTALLATION OF EMERGENCY TRAFFIC  
PREEMPTION EQUIPMENT**

**WHEREAS**, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey has identified a traffic condition that exists at the intersection of NJ Route 38 and Cherry Hill Mall Drive and Hillview Drive in the Township of Cherry Hill, in the County of Camden, which requires the installation of an emergency pre-emption operation in addition to the semi-actuated traffic control signal with pedestrian push buttons and areas of presence detection in order to minimize the possibility of accidents; and

**WHEREAS**, it is necessary to expedite the safe movement and conduct of pedestrian and vehicular traffic; and

**WHEREAS**, the State of New Jersey has proposed a form of agreement pertaining to the installation and maintenance of said traffic signal;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, is hereby authorized to enter into an agreement with the State of New Jersey, acting through its Commissioner of Transportation, for the purpose aforesaid, a copy of said agreement being attached hereto and made part hereof;
