**RESOLUTION AUTHORIZING THE CREATION OF A PAID POSITION OF
EMS PLATOON LEADER**

WHEREAS, there exists a need within the Cherry Hill Fire District #13 in the Township of Cherry Hill, County of Camden, to create a paid position entitled "EMS Platoon Leader" to perform those duties as necessary; and

WHEREAS, the Commissioners of Fire District #13 have determined that they are desirous of creating said position; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, as follows:

1. The position of EMS Platoon Leader is hereby established.
2. The annual salary, benefits and terms and conditions of employment for this position shall be determined by the Commissioners and as otherwise mandated by New Jersey statutory law, and agreed upon contractually.
3. The EMS Platoon Leader shall undertake any and all responsibilities and administrative obligation relative to the Fire District, as determined necessary by Commissioners.
4. The EMS Platoon Leader shall be under the supervision of the Commissioners as designated by the Commissioners pursuant to N.J.S.A. 40A:14-81.
5. This resolution shall take effect following final adoption and publication pursuant to New Jersey statutory law.

NOTICE is hereby given that the above resolution was introduced upon first reading at a regular meeting of the Commissioners held on April 7, 2016 and will be considered for final passage at regular meeting held on May 2, 2016 at 7:00. at 1100 Markkress Road, Cherry Hill, New Jersey at which time and place any person wishing to be heard shall be given the opportunity.
