**RESOLUTION AUTHORIZING THE RENEWAL OF THE SHARED SERVICES AGREEMENT  
BETWEEN CHERRY HILL FIRE DISTRICT #13 AND BOROUGH OF COLLINGSWOOD**

**WHEREAS**, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey and the Borough of Collingswood, County of Camden, State of New Jersey have previously negotiated and approved a Shared Services Agreement that provides for the repair of the Fire Company's apparatus and achieves economies and efficiencies; and

**WHEREAS**, the Board of Fire Commissioners for Fire District #13 is prepared to accept the responsibility for the repair of the Borough of Collingswood's fire apparatus as agreed upon pursuant to the terms and conditions hereafter set forth in the agreement; and

**WHEREAS**, the Board of Fire Commissioners for Fire District #13, and the Borough of Collingswood desire to renew said agreement pursuant to the same terms and conditions as previously negotiated effective from May 31, 2016 to June 1, 2017; and

**WHEREAS**, the State of New Jersey has defined the procedures for the execution of any agreement, and the Agreement between Cherry Hill Fire District #13 and the Borough of Collingswood shall be governed by the Shared Services Act, *N.J.S.A 40A:651 et seq* and the Local Public Contracts Law, *N.J.S.A 40A11-1 et seq*.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners, District #13, Township of Cherry Hill, County of Camden, State of New Jersey, hereby approves and is authorized to execute a Shared Services Agreement with the Borough of Collingswood, County of Camden, State of New Jersey, a copy of which is on file and made a part hereof.
