**RESOLUTION AMMENDING SALARY RANGES FOR PAID EMPLOYEES**

**WHEREAS**, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey, has various paid employees; and

**WHEREAS**, the Board of Fire Commissioners adopted Resolution #16-03-03-16 on March 3, 2016 establishing a range of salaries for employees, and

**WHEREAS**, a correction is needed on the EMT Per Diem Personnel years of experience chart specifically the category listed for "5-9 years (inclusive)" should state "6-9 years (inclusive)".

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Fire Commissioners as follows:

1. Salary ranges for **full-time** civilian employees shall be the following:

Unit Heads	\$ 70,000 - \$ 115,000
Clerk/Administrative Personnel	\$ 35,000 - \$ 65,000
Technical Administrative Personnel	\$ 30,000 - \$ 70,000
Apparatus Mechanic	\$ 51,000 - \$ 70,000 *

2. Range of hourly rates for **part-time** civilian employees shall be the following:

Clerk/Administrative Personnel	\$ 15.00 / hr - \$ 32.00 / hr
Smoke Detector Inspector	\$ 15.00 / hr - \$ 20.00 / hr
Technology Personnel	\$ 25.00 / hr - \$ 35.00 / hr
Adjunct Instructors	\$ 18.00 / hr - \$ 26.00 / hr **
Apparatus Mechanic	\$ 25.00 / hr - \$ 35.00 / hr *

The Board of Fire Commission will determine the position/classification of each job and to re-evaluate and reclassify or regrade existing positions as changes take place in the responsibilities and duties of such jobs from time to time.

The duties of employment of the several officers and employees, except as otherwise provided by statute, shall be set forth by the Board of Fire Commission. The hours of employment and other pertinent working conditions pertaining to these positions shall be determined by the Board of Fire Commission
