RESOLUTION TO ADOPT A TEMPORARY BUDGET FOR PUBLIC EXPENDITURES

WHEREAS, the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey recognizes the need for public expenditures to protect and promote the public safety and welfare of its citizens; and

WHEREAS, N.J.S. 40A:14-78.17, Section 12 amended to read: commencing January 1, 1986, all fire districts' fiscal year shall begin January 1st and end December 31st; and

WHEREAS, necessary funds are needed for the efficient operation of the fire district until the third Saturday in February of 2017, at which time the fiscal year's budget shall be voted upon by the voters of the fire district; and

WHEREAS, commitments and payments for salaries, goods and services must continue for the efficient operation of the fire district; and

WHEREAS, a temporary budget needs be adopted prior to January 1, 2017 with total appropriations not exceeding 14% of the total of the appropriations made for all purposes in the budget for the preceding fiscal year exclusive of appropriations for interest and debt redemption charges and capital improvements.

NOW, THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners, Fire District #13, Township of Cherry Hill, County of Camden, State of New Jersey in accordance with N.J.S. 40A:14-78.17, Section 12, August 1985 that a temporary budget be adopted, not to exceed the amount of \$3,869,329.38 to meet the obligations of the fire district until February 20, 2017.
